Purpose and Scope of the Information Notice

As **NOVA DENTAL VE MEDIKAL HIZMETLER LIMITED ŞİRKETİ**, we take necessary measures to protect your personal data in accordance with Law No. 6698 on the Protection of Personal Data ("KVKK" or "Law"). We process your personal data as a "data controller" for the reasons and methods explained below, in compliance with the KVKK and relevant legal regulations.

Method and Legal Basis for Collecting Your Personal Data

Your personal data may be collected verbally, in writing, or electronically through automatic or non-automatic means via the Company's affiliated units, social media platforms, software used within the company, security cameras, and similar means. Personal data will be created and updated throughout the continuation of your relationship with the Company and may be stored in both digital and physical environments.

Your personal data may be processed and transferred in line with the purposes listed under the "Processed Personal Data and Purposes of Processing" heading, based on your explicit consent as per Article 5(1) of the Law or without the need for consent under the conditions specified in Article 5(2) (a, c, ç, e, f) of the Law.

Special categories of personal data (excluding health and sexual life data) may also be processed under the same conditions. Health-related personal data may only be processed with your explicit consent or by authorized persons under the obligation of confidentiality for the purposes such as public health protection, preventive medicine, medical diagnosis, treatment and care services, and management of health services and their financing.

Your personal data are securely processed in accordance with the Law to fulfill legal obligations or to provide more efficient services.

- Domestic/foreign organizations we contract with or cooperate with.

Data Processing and Retention Period

Your personal data will be processed for the time necessary to fulfill the purposes outlined in this notice, in accordance with the legal data retention periods specified in the relevant legislation. If legal time periods are amended, those changes will be reflected.
